28 th January 2022	<p>Thank you for notifying us of 6 positive covid case(s) at your school, in year 4H, within a 10 day period</p> <p>We are now advising that any pupil or staff member within this class with ANY symptoms of being un well should get a PCR test. This is because cases in this class have continued to rise and the children who are remaining in this class are now contacts of several positive cases. The omicron variant has many different symptoms (not just the 3 classic symptoms of Covid) therefore we would now advise anyone who is un well should get a PCR test. This is not mandatory and those who get a PCR test who are un well (with non-classic symptoms) can stay in school whilst they await the results. Those who have classic symptoms will still need to isolate immediately and get a PCR test (that is mandatory).</p> <p>When booking a PCR test the person should tick that they were advised to get a test by their local health protection/public health team.</p> <p>I have attached a new warn and inform letter to this email which should be sent to parents of children in this class.</p> <p>This class should remain in a bubble until there are less than 3 active cases in the class and follow the recommendations that are in place for a bubbled class, that were outlined previously, if you need information or support around bubbling a class please get back in touch.</p> <p>This advice relates to this specific situation, if you have any new situations in the future please get in touch with the team on 0800 952 1000 to discuss the specifics of that situation and we can advise you further.</p> <p>Please continue to report any cases to us, should you need any further guidance or advice please do not hesitate to contact the team.</p>

Year 5MP should now be placed into a bubble for at least 10 days until and including 6/2/22, further to this date please keep this class bubbled until you have less than 10% of the class as active cases. If you have not done so already please can you send a 2nd warn and inform letters out to this class. Please continue with enhanced cleaning and make sure the rooms remain well ventilated as well as reminding staff and children to increase the frequency of their hand washing.</p> <p>Year 5L should now be placed into a bubble for at least 10 days until and including 5/2/22, Year 1W should now be placed into a bubble for at least 10 days until and including 31/1/22, Year 6W should now be placed into a bubble for at least 10 days until and including 5/2/22,</p> <p>Further to this date please keep this class bubbled until you have less than 10% of the class as active cases.</p> <p>Year 4H should now be placed into a bubble for at least 10 days until and including 31/01/2022, further to this date please keep this class bubbled until you have less than 10% of the class as active cases. If you have not done so already please can you send a 2nd warn and inform letters out to this class. Please continue with enhanced cleaning and make sure the rooms remain well ventilated as well as reminding staff and children to increase the frequency of their hand washing.</p>

<p>7th October 2021</p>	<p>Any unvaccinated staff who work within the same classroom as a positive case for more than half of the day or who have been within 1 metre of the positive case for more than 1 minute, should be sent home to isolate for 10 days from last contact with the positive case.</p> <p>Any vaccinated staff and all pupils who are close contacts should commence daily LFD tests for 7 days post contact, this may be a whole year group if classes mix for different subjects. needs or need 1:1 support.</p> <p>Advice from Public Health</p> <p>Send another warn and inform letter to affected classes and advise to PCR test their children (it is not mandatory). Ask parents to be vigilant of any symptoms of their child, to book a PCR test if their child becomes unwell with any symptoms. Any child with symptoms must not attend school whilst awaiting their PCR results.</p> <ul style="list-style-type: none"> • Classrooms to be deep cleaned • Staff who are contacts to be advised to have a PCR test (it is not mandatory) • Daily LFD test for any contact staff involved for 10 days post exposure • Staff to clean surfaces they have touched after using the staff room – please ensure this is communicated to all staff • If the chairs in the staff room are fabric, these should be cleaned (best they can be) and taken out of action for 72 hours post cleaning • Try and reduce the amount of contact the Nursery class has with other classes, try to avoid assemblies and having the class taught with another class, however the class can play out at break time, the staff can move between classes, the class can have lunch with other classes (try to sit at their own tables if possible).

In addition, two or more cases within a 10-day period in a setting will be monitored by Salford Public Health team.</p> <p>The DfE threshold to use as an indication for when to seek public health advice: For most education and childcare settings, whichever of these thresholds is reached first:</p> <ul style="list-style-type: none"> • 5 children, pupils, students or staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period; or • 10% of children, pupils, students or staff who are likely to have mixed closely test positive for COVID-19 within a 10-day period <p>For special schools, residential settings, and settings that operate with 20 or fewer children, pupils, students and staff at any one time:</p> <ul style="list-style-type: none"> • 2 children, pupils, students and staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period <p>All settings should seek public health advice if a pupil, student, child or staff member is admitted to hospital with COVID-19. They can do this by phoning the DfE helpline (0800 046 8687, option 1), or in line with other local arrangements. Hospitalisation could indicate increased severity of illness or a new variant of concern.
